## Notice Regarding the Schedule for Announcement of Consolidated Financial Results for the Fiscal Year Ended March 31, 2020, and Postponement of the 56th Annual Shareholder's Meeting

**Tokyo, Japan May 13, 2020** ---- Hitachi Construction Machinery Co., Ltd. (TSE: 6305; "HCM") today announced the notice regarding the schedule for announcement of consolidated financial results and postponement of the 56<sup>th</sup> annual shareholder's meeting.

1. Schedule for Announcement of Consolidated Financial Results for the Fiscal Year HCM's consolidated accounting procedures for the fiscal year ended March 31, 2020 are being delayed at subsidiaries by lockdowns in regions around the world due to the spread of COVID-19.

In view of the progress of the accounting process at overseas subsidiaries, etc., today HCM has finally decided the schedule for the announcement of consolidated financial results for the fiscal year ended March 31, 2020 to be disclosed on May 28, 2020.

2. Postponement of the 56th Annual Shareholder's Meeting and Establishment of Record Dates

As described in the above 1, due to delay in the accounting procedures, HCM has decided to postpone the 56th annual shareholder's meeting to July onwards.

- (2) Scheduled date of public notice : May 13, 2020 (Wed)
- (3) Method of public notice : Electronic public notice (to be posted on HCM's website)

As for record dates for dividend payment, it will not be changed from 31 March 2020 as usual, and the specific amount of dividend will be announced as soon as it is ready.
